SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application - Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application - Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Rush-Henrietta used its site-based school improvement planning process (shared decision-making) to gather input and ideas from members of the school improvement teams. These teams are comprised of diverse representative stakeholders that include parents, community representatives, as well as teachers, staff, administrators, and (at the secondary level) students. The school improvement planning process includes review of student data regarding achievement, attendance, behavior, and social-emotional needs, as well as development of action steps to be included in the annual school improvement plan. The teams also assist district leaders with developing proposals such as the ARP grant funding, based on needs identified through the data review. This process includes both Title I schools and those not receiving Title I funding.

The district also gathered input into the development of the plan through the District Parent Advisory Council and Multicultural Parent Advisory Council, which represents parents and students throughout the district, including underserved groups such as students with disabilities, English language learners, economically disadvantaged students, migrant families, and students of color. The Board of Education held public forums where community members and advocates for the disabled and English Language Learners were invited to comment on the plan. The district also partners with community organizations such as the Interfaith Clergy Council, African American Interfaith Council, as well as parents and community in the Title I schools, to solicit suggestions for how to allocate federal grant funds.

The district will continue to engage multiple community stakeholder groups through these organizations and venues as well as the school improvement teams, to monitor the implementation and impact of the funded initiatives.

We plan to continue frequent and thorough disinfecting and mitigation protocols, and will utilize ARP funds to purchase additional supplies and equipment to ensure schools and other district buildings are operated safely for in-person learning.

We plan to continue frequent and thorough disinfecting and mitigation protocols. We will not be using ARP funds for this purpose as we have already reserved sufficient funds in our CARES and CRRSA budgets.

The district uses a variety of measures, including state and local testing, benchmark common assessments, NWEA/MAPS, AimsWeb, and other standardized periodic measures, as well as non-academic measures such as attendance data, behavioral reports, suspension data, formative assessments, classroom observations and other data to gauge student engagement, and social-emotional indicators. All teacher teams will engage in periodic and frequent progress monitoring of academic achievement data and student work, to track growth and progress over time, identify gaps in learning, and design intervention plans that are specific, targeted and measurable (so they can be monitored and adjusted over time as well). Interventions and supports will also include mental health counseling, restorative practices, and social-emotional learning strategies, involving school counselors, social workers, psychologists, behavior specialists, and others. Specific classroom-based instruction will be implemented in alignment with our K-12 counseling plan.

5. Based on the data analysis, the district will utilize multiple strategies to address the impact of lost instructional time, including:

- Restoring full-time Math coaches to our primary schools (grades K-3), to support teachers in delivering targeted academic interventions and
 effective instructional strategies.
- Hiring full-time Math AIS providers in our primary schools, to address identified learning loss and skill gaps.
- Developing "high-impact tutoring" programs before and after school, as well as in the evenings and online, to increase instructional time on task, re-teaching, gap-closing strategies, and other academic interventions.
- Expanding our "intersession" extended-year credit recovery programs at the secondary level, by offering expanded instructional sessions during
 school recesses (such as February and April), to close gaps and get/keep students on track for graduation, especially our underserved subgroups,
 such as English learners and students with disabilities.
- Development of comprehensive K-12 summer programs for 2022, 2023, and 2024 to address basic skills gaps, re-teaching, and enrichment, such as
 foundational reading at grades K-6, ELL literacy support, credit recovery, and remediation for lost instructional time, as well as consultation for
 social-emotional learning and mental health support.
- Expanding after-school programs that assist junior high school students with homework completion and skills review, and extending the program to the intermediate level (grades 4-6).

Rush-Henrietta has allocated significant funds to support teaching positions that will help to address learning loss, close achievement gaps, provide academic interventions, and monitor student growth and progress. These include several reading and math specialist positions, as well as instructional coaches, AIS providers, speech pathologists, a special education teacher, ENL teachers, and tutors.

7. In the space provided below, please describe how the LEA will ensure that the interventions it implements, including but not limited to the interventions implemented under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time, will respond to the academic, social, emotional, and mental health needs of all students, and particularly those students disproportionately impacted by the COVID-19 pandemic, including students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students.

All of the programs and interventions in the district's ARP-ESSER Plan are designed especially to provide support for underserved student populations, and will include funding for transportation so that students/families will be able to participate in any tutoring or other activities that take place outside the school day without regard to economic means, housing circumstances, or migratory status. The district provides a web-enabled device (Chromebook) to all students K-12, which students can use remotely, as some of the programs will be offered online to enhance families' flexibility in scheduling and access. The district also provides web "hotspots" to families who have economic need. Programs will be offered in the evenings, including consultation with mental health and related service providers, to make it easier for families with work scheduling conflicts to participate. Several academic interventions will be specifically tailored to support English language learners, children with disabilities, and others with special needs. Data reviews and progress monitoring will address any potential issues of bias or equity involving student subgroups, such as students of color, including disproportionality in suspensions and identification for special education services.
